Doctoral degree in relevant subject including agriculture, horticulture, Animal husbandry, Extension, engineering etc. and relevant to basic sciences with research work related to agriculture and with 8 years work experience in relevant subject as Scientist/Lecturer/Extension Specialist/ Subject Matter Specialist or in an equivalent position in the pay band-3 (as per 6<sup>th</sup> CPC) of Rs. 15600-39100 with Grade pay of Rs. 5400/ Rs. 6000/ Rs. 7000/ Rs. 8000 having made contribution to research/ teaching/ extension education as evidenced by published work.

- Specialization in implementing extension education programmes.
- The Mandate of Kasturba Gandhi National Memorial trust is to work for empowerment of poor women in rural areas of India through (amongst other things) Agricultural activity. Therefore an understanding and experience of reinforcing agricultural effort by the farmers, specifically women, enhanced productivity, value addition, entrepreneurship, integrated, natural, organic farming with sustainable environmental protection efforts will be desired.

- Applications of the applicants working in Government and non-government organizations, public sector undertakings and autonomous bodies etc. should be forwarded/ submitted through the present employer and must be accompanied with "No Objection" certificate from the employer
